**Non-Disclosure Agreement**

**THIS AGREEMENT** is made between JEFFREY E. DUNAN of Los Angeles, California, Designer of the Wing-in-Surface-Effect Vehicle and Airfoil Catamaran (herein after referred to as 'Designer') and \_\_\_\_\_ (herein after referred to as "Recipient").

**1. Disclosure Terms.** In the course of discussions, Designer may disclose to Recipient certain trade secrets consisting but not necessarily limited to:

(a) Technical information: Methods, processes, formulae, compositions, systems, materials, techniques, inventions, machines, computer programs and research projects.

(b) Business information: Customer lists, pricing data, sources of supply, financial data, marketing techniques or strategies, production methods, or merchandising systems or plans.

**2. I agree that I shall not during - or at any time following** - my discussions and professional relationship with Designer, use for myself or others, or disclose or divulge to others (including future partners, employers, associates or employees), any trade secrets, confidential information, or any other proprietary data of the Designer in violation of this agreement. I further agree not to reverse engineer any process, material or technique revealed to me by Designer – nor shall I support or encourage other parties to do so.

**3. That upon the conclusion of my professional relationship with Designer:**

(a) I shall return to Designer all documents and property of the Designer, including but not necessarily limited to: drawings, blueprints, reports, manuals, correspondence, customer lists, computer programs, and all other materials and all copies thereof relating in any way to the Designer's business, or in any way obtained by me while in the Designer confidence. I further agree that I shall not retain copies, notes or abstracts of the foregoing.

(b) The Designer may notify any future or prospective employer of mine or other third party of the existence of this agreement, and shall be entitled to full injunctive relief for any breach of confidentiality.

(c) Local jurisdiction, in regards to any claims arising from this Agreement, shall be Los Angeles County, California.

(d) This agreement shall be binding upon me and my personal representatives and successors in interest, and shall inure to the benefit of Designer, his successors and assigns.
